

- **Un-authorized trading of entrusted authority**
- **Personal benefit received**
- **Structural**
- **Opportunistic**



CORRUPTION

- **Demoralize** government
- Weaken **policy formulation** and **implementation**
- Diminish **services**
- Cause **fiscal stress**
- Undermine **trust**
- Corrode legitimate **community expectations**

CORRUPTION

- Exist in both **rich** and **poor** countries
- **Nature, extent** and **dynamics** very different



POOR COUNTRIES

- **Water** shortages
- **Illegal logging**
- **Justice administration** compromised
- **Health services** unfairly delivered



POOR COUNTRIES



- **Educational opportunity** denied
- **Procurement** distorted
- **Roads** poorly constructed
- **Telecommunications infrastructure** excludes many



POOR COUNTRIES

- Responses to **natural disasters**
- **Regulatory behaviour in extractive industries**

- **Analysis of corruption**
- **Identify**
- *Types*
- *Activities*
- *Sectors*
- *Places*

TASP

- **Types** - bribery, extortion, cronyism, misuse of information, abuse of discretion
- **Activities** - appointing personnel, procuring services, controlling and regulating activities, issuing permits and licenses, etc.

TASP

- **Sectors** - health, energy delivery, tax administration, justice etc.,
- **Places** - regions, localities or workplaces



TASP FRAMEWORK

- **Controls and processes for control and modification of corrupt behavior**
- **Enhance public sector performance**
- **Pinpointing nature, location and context of public sector corruption**

TASP FRAMEWORK EXAMPLE

- **Type** - bribery (type)
- **Activity** - procurement
- **Sector** - mining
- **Place** – x region
